We have spoken with a consultant and unfortunately it looks like we can't get compliant on the issue of the interior stairs and a variance on this item is not realistic. Although we are only slightly out of compliance it is not something we can challenge. That said, this stairway is behind controlled access locked doors and is only accessible to our parts team which at this time is only one person. It is in no way accessible by the public or our staff in general, which truly mitigates any potential issue with the stairway being the residential standard rather than the public standard.
