WHEREAS, Bylaw No. 1168-00 of the Town of Bonnyville established a Community Policing Committee for the Town of Bonnyville; and

WHEREAS, Section 2 a) i) a) stipulates that the Committee shall consist of seven members, two from Council, two from the RCMP, and three from the public and the Council of the Town of Bonnyville desires to change this section of the Bylaw; and

WHEREAS, the Council of the Town of Bonnyville deems it appropriate to increase the number of members on the Community Policing Committee from (7) Seven to (9) Nine and provide more flexibility with respect to the appointment of members and who they represent;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE TOWN OF BONNYVILLE IN THE PROVINCE OF ALBERTA DULY ASSEMBLED ENACTS AS FOLLOWS:

- 1. In this bylaw:
 - a) "Act" means the Police Act, S.A. 2000 c. P-17 and amendments thereto
 - b) "Council" means the Municipal Council of the Town of Bonnyville.
 - c) The provisions of this bylaw shall be interpreted so as to conform with and be consistent with the provisions of the Act.
 - d) "Committee" shall mean the Bonnyville Community Policing Committee as appointed by Council.
- 2. Establish a Community Policing Committee:
 - a) The Town of Bonnyville Community Policing Committee is hereby established and instituted with the duties hereinafter set forth:
 - i. The Committee shall:
 - a) Consist of nine members, two from Council, two from the RCMP, and five from the public.
 - b) All members will be selected at the organizational meeting of Council.

- c) Council may terminate the appointment of a member for cause.
- d) Where a vacancy is created in the membership of the committee, Council shall appoint a member to complete the remainder of the original term of appointment.
- e) The committee at its first meeting shall elect a Chairperson and Vice-Chairperson from among the public members.
- f) The committee shall hold at least six meetings more or less evenly distributed throughout the year. Special meetings may be called by the Chair by giving written notice at least forty-eight (48) hours prior to the meeting.
- g) A quorum of the Committee shall be a majority of the members.

3. Duties of the Committee:

- a) The Committee may make recommendations with respect to any agreement with the Government of Canada for the use of the services of the Royal Canadian Mounted Police in the Town.
- b) The Committee should act as a conduit for the RCMP to receive community input on plans, priorities and proposed direction.
- c) The Committee should provide recommendations to the RCMP on service level expectations and how to measure results.
- d) The Committee should act as a forum for a review of policing practices and opportunities for community involvement.
- e) The Committee should provide recommendations to the Chief Elected Official of the Town of Bonnyville on the matter of law enforcement in the Municipality and on the implementation of the objectives, priorities and goals established, and on the Municipal Policing Agreement.
- f) The Committee should assist in the preparation of plans for the establishment and development of initiatives and programs.
- g) The Committee should encourage the delivery of programs and services in a comprehensive, cooperative and coordinated method.
- h) The Committee should monitor and evaluate the implementation and impact of Committee plans and programs.
- i) The Committee should monitor and review procedures and current practices and advise on their effectiveness.
- j) The Committee shall not have the power to pass bylaws, enter into contractual arrangements, or pledge the credit of the RCMP or the Town of Bonnyville.
- 4. That Section 2. a) i) a) of Bylaw No. 1168-00 may be amended by Council resolution if Council wishes to change the number or make up of the membership of the Community Policing Committee in the future.
- 5. That Bylaw No. 1168-00 and Bylaw No. 1326-08 and any future amending Bylaws be consolidated.
